A Message from the Interim Rector

Dear Friends in Christ,

write this in the "time between the times," with Lent half over and Easter on the horizon. A sign of this is that our eucharistic preface switches from echoing Jesus' temptation in the wilderness to our preparing "with iov for the Paschal Feast." In witness to the duality of this moment, my letter has two parts, one focuses on Lent and one for Easter.

I need to encourage myself and all of us to continue to make the most of Lent as a time for reflection, selfexamination, repentance and renewal. And vet, like readers of mysteries, our temptation to skip ahead is all too real. At one level, that's not only normal, it's all right. The knowledge that Easter is coming with its ever-fresh affirmation of Love's triumph over death and all that is dark and evil and cruel gives us courage to face the genuine darkness in our world and in our own hearts. Ferris was so powerful a preacher in Boston years ago that a college classmate working on his MBA used to go hear Ferris preachthough he had no intention of ever leaving his Lutheran roots and becoming an Episcopalian. One of Ferris' prayers seems especially apt as we continue our Lenten journey toward another Holv Week:

We acknowledge, O God, in ourselves the desire to seek our own way and to have our own will regardless of what it may cost us or other people. Open our eyes to these facts, unpleasant as they may be, and then so empower us to trust you that we may be prepared to meet the crooked streak that runs through our world and through us, and finally be saved from it, through Jesus Christ our Lord.

I also need to encourage us to make the most of Holy Week and Easter. Our celebration of Easter is enriched if we take to heart the New Commandment

that gives Maundy Thursday its name: the commandment not merely to love, but to love one another as Christ has loved us. Our Easter is enriched if we observe that awful, dread full, agonizing Friday we call "Good" and resist the impulse to flee with the rest of the Disciples. Only if we do take Jesus' death straight, with absolute heart-break and shame, can the new light of Easter dawn with earth-shaking power and hope, and we cry out Alleluia, the Lord is Risen, the Lord is Risen indeed! The great poet George Herbert eloquently affirms that Easter does not merely dawn as one glorious new day, but rather ushers in an everlasting day. I invite you to read and reread Herbert's "Easter."

Christ Risen and realized

athor George Thompson tells of a Jewish rabbi's appeal to Christians during the tumultuous 1930s. On Easter Eve, the rabbi wrote in a newspaper: "I challenge the Christian world to measure itself by the standards of Christ. As long as any group is judged by its creed or color or country in place of its character, Christianity is a sacrilege rather than a sanctity. To this end, I summon Christians everywhere to make this Easter to signify Christ realized and not merely Christ risen."



Sr. Warden's Report

here are multiple short items this month:

State of the Parish

At services, meetings, coffee hours and in individual conversations, it is gratifying to feel the energy and enthusiasm coming from all of you. This situation is supposed to be a time of renewal for a parish. I don't know how it works out for other churches, but the vitality at St. Luke's now is palpable and exciting. Whatever the next rector arrangement turns out to be, we are proving that "a church is a ministering community, not a community gathered around a minister." A church does not belong to the rector, whoever that is. It was created by people to worship and serve God. The clergy are transitory and so are the parishioners. The great spirit of caring and community at St. Luke's, the origin of which is beyond the memory of any of us, lives on and we are charged with being stewards of it.

Rector Search Process

Canon Neesa Ellgren Shepley, the Diocesan Transition Officer, told the Vestry and Profile Committee members who met with her on March 25 that the St. Luke's rector search process appeared to be on time and on track. At the present stage, this is largely attributable to the efforts of Juli Mimnaugh and the Profile Committee that she chairs very ably, but there is plenty for the rest of us to do. Selection of the Search Committee will be done in April. If you have an interest in serving on that committee, please contact me, preferably with a note or an email message stating something about your qualifications. Experience in hiring and evaluating employees is particularly sought. Many parishioners have expressed interest in serving on the Search Committee, but the Vestry intends that it will be a manageable size, so please understand that not everyone can be chosen.

It is vital that we call a priest who is a good fit for St. Luke's and the community. We want that person to be happy and comfortable here and we want to be at ease with them. In furtherance of that objective, we intend that this Parish Profile will be candid and forthright in describing our parish and the local community and we will be as specific as possible about the skills and traits of the priest who would be well-suited here. Juli is soliciting input from everyone about what they would prefer in that regard. It is imperative that everyone respond by stating their preferences. Please think hard about this and then fill out a survey card or send an email.

Because we are seeking a rector, not the CEO of a software company, we can ask that the power of the Holy Spirit support and direct our efforts. Please pray that we will be guided to a successful conclusion and please pray for the priest who will be called as our next rector, even though we do not yet know who that is.

Gifts of Time and Talents

Dry weather will probably appear during the next month or so, present appearances to the contrary, and there will be maintenance and cleaning projects undertaken inside and outside of the church building. Please be alert for announcements of these from the Junior Warden, the Gardening Angels and others. Stewardship is not just about pledges, we also are charged with taking care of the facilities left to us by parishioners who were here before us.

Gifts of Appreciated Property

Father Morgan and Dennis James spoke at the Annual Meeting about the tax advantages of making gifts of appreciated property to support charitable organizations during your lifetime. I hope that your favorite

Worthy cause is St. Luke's. If you have, as a typical example, some stock that has appreciated in value (although it can be any property), you would have to pay income tax on the capital gain if you sold it. If, however, you give the stock to St. Luke's, you will pay no tax on the increase in value, but you will get an income tax deduction equal to the higher value at the time the donation is made. This is not a "gimmick" or a "loophole." Congress added this feature to the Internal Revenue Code a long time ago to encourage charitable giving.

If you wish to make such a gift, please contact Myrna Rafalovich or Mike Dawson. There are some forms to complete so that the brokerage that serves the St. Luke's Memorial Trust can transfer ownership, but it is not an arduous thing to do.

Outreach through Poultry

As you know, Starr and Joe Hungate have a flock of about ten chickens, including a rooster, and Starr sells the eggs during coffee hours. The proceeds are donated to international relief organizations. It's a worthy ministry that begins with poultry farming and that is pretty cool.

Because they are moving to Arizona, the Hungates must find a good, new home for this little farming operation. It would be nice if the birds continued to support a ministry, but that is not a prerequisite. If you have an interest in taking over this little egg production operation, or if you know anyone who does, please contact Starr Hungate.
